1. <u>Introduction</u>

1.1 On 1st June 2020 Members considered a proposed public consultation exercise on the implementation of a number of controls designed to address anti-social behaviour associated with irresponsible dog ownership.

- 1.2 This report gives Members the opportunity to consider the results of the completed public consultation exercise to enable decisions to be made about the implementation of relevant, lawful and proportionate controls.
- 1.3 The potentially contentious nature of this important area of the Council's business is acknowledged.

Members who have previously expressed an interest in this area of work were invited to discuss the previously submitted report - in advance of the Strategy and Resources Committee meeting on Friday 13th November.

The report was updated at the request of Members – resulting in this updated version.

2. Recommendations

- 2.1 It is recommended to Full Council that Members approve the measures identified in section 4.9 of this report.
- 2.2 It is also recommend that Committee consider any further controls and make such recommendations to Full Council as are considered appropriate.

3 Reasons for Recommendations

3.1 To enable controls to be put in place which better address anti-social behaviour associated with irresponsible dog ownership.

4 Report

4.1 Members' have previously been made aware of the significant and positive public health, social and economic benefits of dog ownership.

A number of published papers for example have evidenced the savings to the NHS through improved physical and mental health of owning a companion dog.

While the majority of dog owners are responsible, there is unfortunately an irresponsible minority who do not pick up after their dog or allow their dogs to run out of control.

4.2 The Anti-Social Behaviour, Crime and Policing Act 2014 contains provisions for local authorities to introduce Public Space Protection Orders' (PSPO), designed to address anti-social behaviour.

To implement a PSPO, a local authority must be satisfied on reasonable grounds that the activity has been or is likely to be detrimental to the quality of life of those in the locality, and that the activity is likely to be persistent and unreasonable in nature.

The PSPO can either prohibit the activity or make specific requirements on those who are carrying out the detrimental activity.

- 4.3 The recent public consultation exercise designed to inform the evidence base for implementing any new PSPO, by pursuing the least restrictive approach is now complete.
- 4.4 Considering the number of responses received (3000+), and the need for absolute transparency and robustness in the evaluation of this data, an external consultant was commissioned to undertake an independent analysis of the responses received.
- 4.5 The consultant's findings are included as Appendix 1 to this report with the key findings summarised below:
 - There is majority *support* for the controls identified in the consultation exercise, in relation to:
 - controlling dog fouling
 - dog control (excluding the 6 busy amenity beaches and the Tarka Trail)

- public cemeteries
- o enclosed children's play areas
- formal sports pitches
- o Braunton Burrows special area of conservation
- high tide resting sites
- There is majority opposition for the controls identified in the consultation exercise, in relation to:
 - o proposals for dog control on the 6 busy amenity beaches
 - o proposals for dog control on the Tarka Trail
- The Environmental Protection Team receives the following reactive requests for service in relation to this area of work:

4.7 In relation to those aspects of the consultation which present a majority opposition (the 6 main amenity beaches and the Tarka Trail), Officers' have further liaised with the landowners to clarify their views.

This information is attached as Appendix 2 to this report.

- 4.8 On consideration of the data presented in 4.5, 4.6 and 4.7 as well as their routine observations from carrying out their day to day duties Officers' are satisfied that there is the legal justification for implementing a suite of measures to enable the Council to better address anti-social behaviour associated with irresponsible dog ownership.
 - 4.9 It is recommended that a new District wide PSPO is implemented incorporating measures to:

- 1 issue Fixed Penalty Notices (FPNs') of £100 to people who do not pick up their dog waste in all areas open to the public.
- 2 issue FPNs' of £100 to people who do not place their dog on a lead of 2.0m length or less in any public area when directed by a suitably delegated person / Officer - where that person / Officer is satisfied that the dog is out of control by way of being at large and not on a lead - and / or poses a nuisance or danger to people or other animals.
- 3 issue FPNs' of £100 to people who walk or exercise their dogs 'off lead' in any cemetery open to the public.
- 4 issue FPNs' of £100 to people who allow their dogs to be present on any formal sports pitch, or enclosed children's play area.




Figure 1 - High Tide Roosting Sites in North Devon

- issue FPNs' of £100 to people who allow their dogs to be present within the vicinity (to be defined on a site specific basis) of land used as a High Tide Roosting Site (as identified in Appendix 3, Figure 1) between 1st October and 31st March.




Figure 2 – Croyde Bay

- 6 issue FPNs' of £100 to people who allow their dogs to be present on Croyde Bay (as defined in Appendix 3, Figure 2) between, 1st May and 30th September.
- 7 issue FPNs' of £100 to people who walk or exercise their dogs 'off lead' in the dunes behind Croyde Bay (as defined in Appendix 3, Figure 2) between, 1st May and 30th September.




Figure 3 – Combe Martin Beach

- 8 issue FPNs' of £100 to people who allow their dogs to be present on Combe Martin Beach (as defined in Appendix 3, Figure 3) between, 1st May and 30th September.
- 9 issue FPNs' of £100 to people who walk or exercise their dogs 'off lead' in certain parts of Braunton Burrows during certain times of year as defined by the landowner.
- 10 exempt people who have an assistance dog registered with a member organisation of Assistance Dogs UK from these controls.
- 4.10 It is recommended that the Head of Environmental Health and Housing Services is given authority to delegate enforcement powers to other groups

where it can be demonstrated that they hold the appropriate competencies – for example Police Officers', Parish Council Officers' and specific individual landowners on request.

A programme of accreditation - which takes into account the requirements of all legislation and associated guidance - shall be put in place to enable a robust assessment of competence to take place before such delegation is given.

- 4.11 All existing signage on NDC owned land will be replaced to provide absolute clarity about any controls which are in place in a given location. Whilst the final designs are not yet complete, the general appearance and style of the new signage is currently proposed to be consistent with the working examples provided in Appendix 4 to this report.
- 4.12 In relation to the proposed controls for High Tide Roosting Sites, detailed maps will be drawn up for each site to clearly identify the exact areas to which the controls refer.
- 4.13 Individual landowners who request additional controls to be introduced on their land will be required to install signage as per the finalised Council designs.
- 4.14 A high profile communications exercise will be undertaken to promote responsible dog ownership and to ensure there is a high level of awareness of the controls amongst the Community.

5 Resource Implications

- 5.1 The setting up of any new PSPO can be undertaken within existing resources. The cost of the new signage is estimated to be in the region of £5k which can be met from existing revenue budget.
- 5.2 Enforcement of the PSPO can be undertaken by the Council's Officers', and by other groups where the Council is satisfied that they hold the appropriate competencies as detailed above.

PUBLIC SPACES PROTECTION ORDER

Section 59 Anti-Social Behaviour, Crime & Policing Act 2014

A general order applies throughout North Devon directing responsible behaviours and dog controls as required.



NO FOULING

Dog owners/walkers must clear up Dog faeces is to be promptly removed Dispose of the waste appropriately



DOGS ON LEADS

Dog permitted if kept on leads Fixed leads of no more than 2m in length Respect the sensitivities of others



DOGS EXCLUDED

Dogs are excluded from this area Assistance dogs may be exempt Respect the sensitivities of others

Offenders will be liable to a fixed penalty fine or prosecution. Further details can be found on our website www.northdevon.gov.uk



PUBLIC SPACES PROTECTION ORDER

Public Spaces Protection Orders can regulate irresponsible behaviour and offenders will be liable to a fixed penalty fine or prosecution for non-compliance. To assist a common understanding and easy identification of the condition in various places, we adopted a "traffic light system".

These symbols will guide and remind you...



Exercise freely

Be mindful of sensitivites



Dogs on a lead

May be directed for multiple reasons



No dogs allowed

May be temporary or permanent exclusions
