1. INTRODUCTION

- 1.1. The Climate leads at North Devon and Torridge District Councils, Cllrs Lofthouse and Hames respectively, have been appointed to the Joint Planning Policy Committee to provide a link between the Local Plan Review and the Councillor Climate Working Groups.
- 1.2. This report provides the Committee with a summary of discussions on the Local Plan Review at the North Devon Climate Action Team meeting on 28th June and Torridge Councillor Climate Change Working Group on 30th June.

3. REASONS FOR RECOMMENDATIONS

3.1. To provide the Committee with confidence that Councillors are working collaboratively with relevant groups to ensure the Local Plan Review will incorporate actions to support delivery of the UK's environmental targets, including the commitment to achieve net zero carbon by 2050, to protect 30% of UK land by 2030 etc

4.1. As the new Local Plan will cover a period up to about 2045, it will need to contain strong policies to protect and enhance our environment if we are to achieve the targets set by Government.

4.2. Discussions:

- The Local Plan should be environment-led;
- Local Plan will need to contain policies to achieve net zero development, above current Building Regulations;
- Presumption that Biodiversity Net Gain will be delivered on site in most instances, in line with current guidance from numerous bodies eg TCPA etc;
- No toleration of developers who remove biodiversity from site to make it easier to deliver Biodiversity Net Gain.
