I received the Application for Vintage 21 Horse Lorry, Croyde located at Grid Reference 244401 139182 on the **24**<sup>th</sup> **of June 2022**. The Due Date was the **22**<sup>nd</sup> **of July 2022**. The following are my updates I have placed on the Devon and Cornwall Police Licensing System.

### 4th of July 2022.

Attended the location on Friday 1st July. The Applicant did not appear, and I phoned her. She stated that she was very busy and tired. She went onto say that could she discuss the Application on the phone. I objected and re-arranged the visit for 1300 Hours Friday 8th July.

## 11<sup>th</sup> of July 2022.

Attended the location at 1307 Hours on Friday the 8<sup>th</sup> of July 2022 and spoke to the Applicant. The proposed DPS, was present. As I attended the Croyde & Georgham Parish Council Meeting on Thursday 30<sup>th</sup> June I am aware of the concerns of both the Council and residents. However, as explained there were **eleven** (11) **TENs** for the mobile bar both at Down End Car Park and behind the Blue Grove where the current Application is for. There have been **NO** Police Logs for any of the TEN's. I discussed the Application with the Applicant as well as CCTV, timings, only three pumps providing cider, Peroni and wine, deposit on Polycarbonate glasses, fake ID's and wooden bridge leading to the car park to the rear of the village hall. Also, what was discussed was the Objections, as I had discussed with NDDC on the phone prior to the visit. I will complete some Proposed Conditions send them to the Applicant and will await a reply.

### 19<sup>th</sup> of July 2022.

Email received from the Applicant accepting the Proposed Conditions. The Police will not be making any representations regarding this Application.
