Topic: Approval & Release of S106 Public Open Space Funds - Fremington

Report by: Head of Environmental Enhancement

- 1. INTRODUCTION
  - 1.1. This report seeks to allocate S106 public open space funds to two projects in the Fremington ward.
- 2. RECOMMENDATIONS
  - 2.1. That Strategy and Resources Committee allocates:
  - 2.2. £55,215 to Fremington Parish Council for the replacement of play equipment at Ellerslie Road play area
  - 2.3. £39,868 to Fremington Parish Council towards the replacement of play equipment at Beechfield
  - 2.4. Subject to approval of 2.1, 2.2 and 2.3 above, that Strategy and Resources Committee recommends Council vary the capital programme by £95,083 and that funds be released subject to a funding agreement upon such terms and conditions as may be agreed by the Senior Solicitor for external projects.

#### 3. REASONS FOR RECOMMENDATIONS

- 3.1. To allocate funds in line with the requirement of S106 agreements.
- 3.2. To protect and enhance public open space.
- 4. REPORT
  - 4.1. Over recent years, Fremington Parish Council has had to remove several pieces of play equipment from the Ellerslie Road play area due to its old age and poor condition. The remaining equipment is old and also in need of replacement. There is a high demand for the play area, as recently demonstrated by a group of pupils from Sticklepath School approaching NDC Councillors and asking for the equipment to be replaced.
  - 4.2. Fremington Parish Council has received and produced written quotes from a supplier to replace this equipment and requested that this is funded using S106 Public Open Space Funds.
  - 4.3. Similarly, equipment at Beechfield Play Area is in need of refurbishment and replacement. The last time a similar overhaul was undertaken here was 10 years ago in 2013, so Parish Council Committee members have again requested a contribution for this scheme form S106 Public Open Space funds. The Parish Council will part fund this project itself.
