1. INTRODUCTION

- 1.1. In July 2019 North Devon Council declared a 'Climate Emergency'. This was in recognition of the science and evidence of the impacts that climate change is having on our environment, population and communities. This declaration committed North Devon Council to reach net carbon neutrality by 2030.
- 1.2. In 2022 members approved our first Carbon, Environment and Biodiversity Plan and we are committed to reviewing, updating and presenting this to members on an annual basis.
- 1.3. Publication of the 2023 update of the plan was delayed due to election of a new Council in May 2023.
