QUOTATION FOR INTERNAL RELINE OF No 2 Cremator FT2 S/E – LH.

To supply labour and materials to carry out Internal Reline to cremator as follows:-

We will protect the floor in the immediate area of the cremator, however we cannot be responsible for any damage to the floor between the immediate work area and the external storage area.

We will screen-off working the area and protect other equipment.

Old refractories to be removed, followed by replacement.as required, generally as listed

- Hearth and support wall
- Reline Charge Door
- Offtake passage wall and the supporting wall below
- SCC roof
- Repairs in SCC passage as required
- Works would be carried out from Monday to Friday/Saturday with the cremator service cooled from the preceding Friday

Total Price £37,795.00 + VAT

The reline would take approximately 5/6 days, and work could commence to your reasonable requirements.

SAFETY NOTIFICATION

If your site has Flue Gas Treatment Plant fitted there is a potentially serious Health and Safety issue to be considered. Before any refractory work can be carried out the cremator must be temporarily physically isolated from the common duct to prevent hot flue gases reaching the workers. This will be carried out by Facultatieve Technologies and is included in this quotation.
