Topic: Amendment to Annexe 2 to Part 3 Constitution

1. INTRODUCTION

1.1. An amendment to the delegated power given to the Chief Executive to allow for an ability to approve early retirement for staff where there is a small pension strain cost (not material) by a member of staff.

2. RECOMMENDATIONS

2.1. The Council varies paragraph 3.25 to Part 3 Annexe 2 of the Constitution with the addition of the underlined text as follows:

To determine applications for flexible and early retirement and also for early release of pension where the decision will not result in a net cost to the Council calculated over the following six months from the applicable date.

3. REASONS FOR RECOMMENDATIONS

- 3.1. To allow the Chief Executive to approve early retirement applications where there is a small cost but these small costs are offset by any changes within the service such as the postholder reducing their hours or other structural changes as part of their request put forwards by their Manager, resulting in net savings offsetting the above cost and providing an ongoing saving.
- 3.2. Any early retirement application that incurs a more substantive cost remains reserved to the Governance Committee to approve.

4. REPORT

4.1. Currently at paragraph 3.25 of the scheme of officer delegations for the Chief Executive (in Annexe 2 to Part 3 of the Constitution), it provides the delegated power:

To determine applications for flexible and early retirement and also for early release of pension where the decision will not result in a net cost to the Council.

4.2. There are, and have been in the past, occasions where there may a small pension strain cost (not material) by a member of staff requesting flexible or early retirement. In most cases, these small costs are offset by any changes within the service such as the postholder reducing their hours or other structural changes as part of their request put forwards by their Manager,



resulting in net savings offsetting the above cost and providing an ongoing saving.

- 4.3. However, the way the delegation is written means that any cost coming forwards on pension strain (even if very small, for instance less than £100) means that officers currently have to take a report to Governance Committee to ask members to approve such a retirement case, even if there were significant savings from reduced hours to offset the non-material cost.
- 4.4. What is therefore proposed is to amend paragraph 3.25 of Annexe 2 to Part 3 of the Constitution to reflect the wording set out in recommendation 2.1 that in essence would allow the Chief Executive to approve these minor occasions where there is a small net cost but the initial savings achieved cover off this net cost over the following few months.

5. RESOURCE IMPLICATIONS

5.1. Approving this change should allow for small salary savings by making approval of early retirement applications, as covered by the revised wording, more efficient rather than having to wait for the next Governance Committee.

6. EQUALITIES ASSESSMENT

6.1. It is considered that this proposal has no relevance to equalities and the protected characteristics because it is not changing any policy as to how early retirement is considered, only who approves it if there is no net cost over the 6 months following the applicable date.
