If the interest is not in the authority's register, and is not the subject of a pending notification, the member must notify the authority's monitoring officer of the interest before the end of 28 days beginning with the date when the member first becomes aware that he has a disclosable pecuniary interest: Localism Act 2011 s 31(7).

A director includes a member of the committee of management of a registered society within the meaning given by the Co-operative and Community Benefit Societies Act 2014 s 1(1), other than a society registered as a credit union: SI 2012/1464 reg 1(2) (as amended by SI 2014/1815).
