A 'body in which the relevant person has a beneficial interest' means a firm in which the relevant person is a partner, or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest: SI 2012/1464 reg 1(2). A director includes a member of the committee of management of a registered society within the meaning given by the Co-operative and Community Benefit Societies Act 2014 s 1(1), other than a society registered as a credit union: SI 2012/1464 reg 1(2) (as amended by SI 2014/1815).

10 Schedule question E1—land

'Land' excludes an easement, servitude, interest or right in or over land that does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income: SI 2012/1464 reg 1(2).
